## **Pesticides, PPE and You - 10:30AM to 11:30AM**

Andrea Sawatzky, Health Canada

This session will explain how Health Canada's health risk assessment leads to specific requirements on pesticide labels including personal protective equipment (PPE), restricted entry intervals (REI), precautions and more.

Andrea was born in Thompson, MB, and spent six of my childhood years in Indonesia and Singapore. She attended the University of Manitoba and obtained a Bachelor of Science with a major in Zoology and a Bachelor of Science in Agriculture. After graduation, she moved to Alberta where she started working for the Federal Government. Her first job was as a Primary Products Inspector/Grader for the Meat Hygiene department of what is now called the Canadian Food Inspection Agency (CFIA). She then switched agencies and has worked with Health Canada's Pesticide Compliance Program as a Pesticide Compliance Officer in Calgary for the past 20+ years.



## **The Impact of Invasive Annual Grass on Grassland Biodiversity and Soil Carbon Stocks - 11:30AM to 12:30PM**

Vicki Maloney, Envu

This presentation will center on the research conducted in support of Envu's objective to facilitate the restoration of over 2 million acres of native biodiversity by 2030. It will further investigate the impact of invasive annual grasses (IAGs), such as *Bromus tectorum* and *Ventenata dubia*, on soil carbon stocks. IAGs pose a threat to rangeland biodiversity, productivity, and soil carbon stocks across the western US and Canada. The findings from studies assessing plant community responses on operational sites treated with indaziflam for invasive annual grasses in the western US will be presented. Additionally, the presentation will cover results related to changes in soil carbon stocks caused by invasive grass infestations.

**Emergency Response: OK I Screwed Up ...Now What! - 1:15PM to 2:15PM**

Marty Winchell, Veseris

This session will go through essential spill prevention measures by mastering proper chemical loading, mixing techniques, and preventing slip-related incidents. Mitigate mechanical failures through routine equipment inspections, ensuring timely part replacements to avoid breakdowns. Evaluate the financial aspect by weighing repair costs against potential spill incidents. Be prepared for spills with a clear hierarchy of contacts to notify and follow a systematic documentation and cleanup process. This comprehensive approach ensures efficient spill prevention, minimizes risks, and safeguards against environmental and financial repercussions.

Marty is a key account manager for Veseris Canada involved in the sales and support of Vegetation Management solutions for professional applicators managing rights-of-ways, roadsides and non-crop land areas. Previously working for municipal government, he was involved in the vegetation management and range and pasture spraying and training of staff. Marty has a degree in agriculture, is a train the trainer for authorized assistants, was a fire fighter for 12 years and farms in Rocky Mountain House, he is also the current vice chair of the Alberta Lamb Producers and a guitar player for the band Ginger Snap.

## Learning from Pesticide Incidents - 2:15PM to 3:15PM

This presentation will cover common incidents that Alberta Environment and Protected Areas Compliance officers work through and how a pesticide applicator can learn from this to enhance professionalism in the field of pesticide application.

Devon is the Pesticide Certification Specialist with Alberta Environment and Protected Areas and sits on Canada's Pesticide Education, Training and Certification Working Group. This group is responsible for the National Standard and related pesticide education initiatives including the development of Canadian basic knowledge requirements for pesticide applicators. Devon has worked with Alberta Environment and Protected areas for 16 years focusing on public education, compliance and pesticide certification. She currently resides in Northern Alberta with her husband and two kids and can often be found hiking or gardening.
